Town Manager's Coronavirus (COVID-19) Statement
March 16, 2020

On March 15th, Governor Charlie Baker announced the following additional prevention measures to stem the outbreak of coronavirus in the Commonwealth.

- A three-week suspension at all public and private schools effective Tuesday, March 17th through April 7th (day and residential special education schools are exempt from the closure mandate).
- All bars and restaurants in Massachusetts will be shut down to on-premise consumption starting tomorrow through April 17th. Take-out and delivery, will still be available, as applicable.
- Gatherings larger than 25 people are also banned (churches, clubs, private events).

Grocery stores and pharmacies will still be open. Governor Baker also asked that people should not be considering time off from work or school as an extended break and to take social distancing seriously. "We have a lot of work ahead of us," said the Governor on the coronavirus pandemic. "This is going to be a marathon, not a sprint."

Watertown Public Schools

This week at the Food Pantry: All food pantry items will be pre-bagged for pick-up. Only 1 client will be allowed to enter the building at a time to pick up their bags. Please wait patiently in the parking lot and remember an umbrella if the weather turns to rain.

Watertown Free Public Library

The Watertown Free Public Library will be **closed through Monday, April 6th**. No holds will be available for pickup while the Library is closed. The Minute Library Network (MLN) will extend all due dates to at least mid-April. Please keep your borrowed items at home, even if they are overdue. Items that were recently returned may not be removed from your account immediately. Closure-related fines will be removed from your account. This may not happen immediately. You may see fines accumulate for overdue items you keep at home, or items that were never checked in at the Library. Please don't worry about it. Town Manager's Coronavirus (COVID-19) Statement
March 13, 2020

On March 10th, Governor Charlie Baker declared a State of Emergency in Massachusetts to support the Commonwealth's response to the outbreak of Coronavirus. The state of emergency allows the Commonwealth to take certain actions that may be necessary to manage the coronavirus outbreak.

As a follow-up and in accordance with guidance from the Massachusetts Department of Public Health (MDPH), and in an effort to balance the ability to continue to provide important services and to protect the health and safety of the residents of Watertown, the Town is taking the following measures at this time. These measures could be extended or shortened as the Town receives additional guidance from the Commonwealth. The Town of Watertown is moving forward with these precautionary measures in an effort to prevent and slow the spread of COVID-19.

As you are aware, Dr. Deanne Galdston, Superintendent of Schools sent a communication to our community last night informing Watertown Public Schools will close starting this afternoon and through Friday, March 27th (see link https://www.watertown.k12.ma.us/news/what_s_new/coronavirus_updates).

The Watertown Council on Aging/Senior Center is closed for activities and exercise classes today through the end of March. The Senior Shuttle Bus will continue to operate for grocery shopping, and we will continue to serve seniors with appointments for medical transportation, AARP tax services, SHINE counseling, and case management. Walk-in service for Senior Parking Permits is suspended until further notice, but please call the Senior Center for renewal and purchase information. The Watertown Food Pantry will continue to operate on its regular schedule, Tuesdays from 10:00-11:30 AM and Thursdays from 4:00-6:00 PM at 80 Mount Auburn Street.

The Senior Center staff are available to answer your questions and to help connect you to resources you need. Call the Senior Center between 8:30 AM – 5:00 PM, Monday through Friday, at (617) 972-6490 for updates and further information.

The Watertown Free Public Library will be closed starting tomorrow, Saturday March 14th through Friday March 27th.

All programs offered by the Watertown Recreation Department will be cancelled through Sunday, March 29th. Field and picnic permits scheduled from today through March 29th are also cancelled.

The John A. Ryan Arena will be closed starting tomorrow, Saturday March 14th through Friday March 27th

Town Hall will remain open during normal business hours for residents to access essential services. We ask that residents utilize online services, or utilize telephone or email to contact offices to the extent possible. Boards and Commissions will continue on a as needed basis. We ask that residents who need to visit Town Hall, practice social distancing (6 feet).

As the Town takes these measures, there may be additional measures forthcoming.

Please continue to take the following actions to limit the spread of COVID-19:

- Practice social distancing – when in public spaces try to remain at least 6-feet away from others.
- Stay home if you are sick – and avoid close contact with others.
- Cover your mouth – when you cough or sneeze use a tissue or your inner elbow, not your hands.
- Wash your hands – with soap and warm water or use an alcohol-based sanitizing gel.
